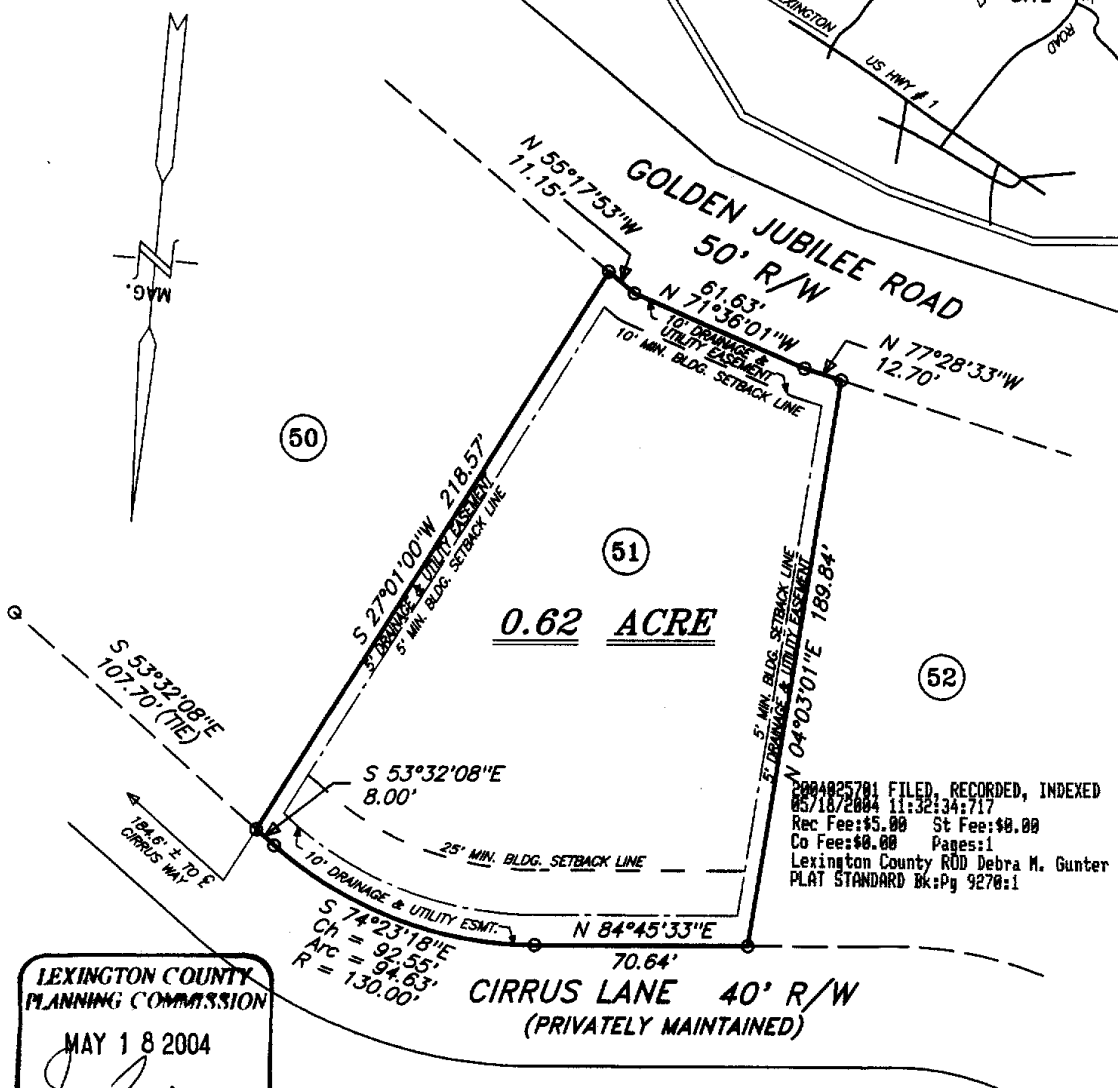
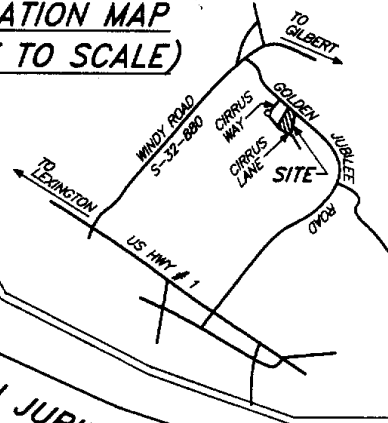


**LOCATION MAP
